**SETTLEMENT AGREEMENT**

---

**I. Introduction**

Pursuant to Rule 4901:2-7-11 of the Ohio Administrative Code (O.A.C.), Jessica and Mark Trucking LLC (Respondent) and the Staff of the Transportation Department of the Public Utilities Commission of Ohio (Staff) enter into this Settlement Agreement and urge the Public Utilities Commission of Ohio (Commission) to adopt the same.

It is understood by the Respondent and the Staff that this Settlement Agreement is not binding upon the Commission. This agreement, however, is based on the Respondent's and the Staff's desire to arrive at a reasonable result considering the law, facts, and circumstances. Accordingly, the Respondent and the Staff believe that the Commission should adopt this Settlement Agreement.

This Settlement Agreement is submitted on the condition that the Commission adopts the agreed upon terms. In the event the Commission rejects any part of the Settlement Agreement, or adds to, or otherwise materially modifies its terms, each party shall have the right, within thirty days of the date of the Commission's entry or order, to

file an application for rehearing that includes a request to terminate and withdraw from the Settlement Agreement. Upon the application for rehearing and request to terminate and withdraw from the Settlement Agreement being granted by the Commission, the Settlement Agreement shall immediately become null and void. In such event, the parties shall proceed to a hearing as if this Settlement Agreement had never been executed.

## **II. Procedural History**

- A. On April 4, 2008, a vehicle operated by the Respondent and driven by Mark Wiesner was inspected within the State of Ohio by personnel of the Ohio Department of Public Safety. The inspection resulted in the discovery of two apparent violations: (1) package not secure in vehicle in violation of 49 C.F.R. § 177.834(a); and (2) no placards and/or markings when required in violation of 49 C.F.R. § 177.823(a).
- B. The Staff timely served the Respondent with a notice of preliminary determination in accordance with O.A.C. Rule 4901:2-07-12 for Case No. OH3207300553C. The total forfeiture assessed the Respondent by the Staff was \$855.00 for the alleged violations.
- C. The Respondent made a formal request for an administrative hearing pursuant to O.A.C. Rule 4901:2-7-13.
- D. The parties have negotiated this Settlement Agreement, which the parties believe resolves all of the issues raised in the notice of preliminary determination.

### III. Settlement Agreement

The parties hereto agree and recommend that the Commission find as follows:

- A. The Staff and the Respondent agree that the Respondent does not contest the violations referenced above. Further, the Staff and the Respondent agree that the Respondent will pay a civil forfeiture in the amount of \$598.50.
- B. The Respondent agrees that the citations may be included in the Respondent's Safety-Net record and history of violations insofar as they may be relevant for purposes of determining future penalty actions.
- C. The Respondent shall have thirty days from the entry of the Commission order adopting the Settlement Agreement to pay the forfeiture of \$598.50. The payment shall be made using a certified check or money order payable to "Treasurer State of Ohio" and mailed to PUCO Fiscal, 180 E. Broad St., 13th Floor, Columbus, Ohio 43215-3793.
- D. This Settlement Agreement shall not become effective until adopted by the Commission. The date of the entry or order of the Commission adopting the Settlement Agreement shall be considered the effective date of the Settlement Agreement.
- E. This Settlement Agreement is made in settlement of all factual or legal issues in this case. It is not intended to have any effect whatsoever in any other case or proceeding.


#### IV. Conclusion


