- (1) The Dayton Power and Light Company (DP&L) is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of this Commission.
- (2) On October 10, 2008, DP&L filed an application for a standard service offer (SSO) pursuant to Section 4928.141, Revised Code. This application is for an electric security plan in accordance with Section 4928.143, Revised Code.
- (3) By entry dated February 2, 2009, the attorney examiner scheduled the evidentiary hearing in this matter to commence on February 11, 2009.
- (4) In order to provide customers of DP&L a reasonable opportunity to provide public testimony in this proceeding, the following local public hearings will be conducted on the following dates:

The notice should not appear in the legal notices section of the newspaper. Further, the attorney examiner finds that the notice of the public hearing proposed by DP&L should be approved.



ORDERED, That DP&L publish notice of the hearings as set forth in Finding (5). It is, further,


