I respect Fully ask you to read my Letter of Confern I have been informed by the Office of the OHIO Consumers Counsel (O.C.C.) that DayTon Power and Light (D. P. &L.) has filed a proposed electric security plan with (PUCO). The plan would allow for increases in rates for several items, including fuel and purchased power through 2010. I for one am a fair and reasonable man and can understand certain recovery costs, but the O.CC., and my entire neighborhood oppose these costs as they have been prohibited by a previous case, and we simply cannot afford another rate hike. In addition, the Utility D.P&L would raise rates again in 2010 to include a surchange to customers to cover these costs. Customers would have to pay a carrying charge (or interest) on any deferrals at a rate of 13.32 percent. The costs proposed in D.P&L's plan are higher than what consumers should be expected to pay. Immigration: Illegal immigration must stop. Our borders must be secure. I have supported and cosponsored legislation to stop illegal aliens, terrorists, drug smugglers, and other criminals from coming across our Southern border. Illegal immigration costs the United States taxpayers billions every year through increased health care costs, social service utilizations, emergency room fees, prison expenses, and in other areas. For example, of the 189,000 federal prisoners, 50,000 are illegal aliens costing the taxpayers millions of dollars for their incarceration.

Amnesty for Illegal Immigrants: I oppose granting amnesty for those persons who come into the United States illegally. The current Senate legislation would reward illegal immigrants by giving them a glide path to citizenship. Amnesty did not work in the 1980s. Amnesty did not work in the 1990s, and it will not solve the problem now. Amnesty only encourages more illegal entry into the United States. Congress, the United States Senate, and the President need to adopt my position of a strong NO to amnesty.

English as the Official Language: I continue to support English as the official language of the United States of America.

Energy Costs: The United States must be free of foreign fossil fuel. Freedom from the Middle Eastern sheiks, Nigeria, and Venezuela is necessary for a continued bright future for our country. We cannot allow OPEC to control our energy supply. I support drilling and energy production in this country.

Being free of a need for foreign fossil fuel will enable us to be less involved in the shifting sands of the Middle East.

Tax Reductions and Fairness: I support the elimination of the Death Tax. Death should not mean the end of the family farm or the family business. Under current federal law a 50% death tax often precludes families from having

the homestead or their parents business.

I support and have voted to terminate the current IRS Code at a date determined in the future so it can be replaced with something simpler and fairer. 
