1	MS. BOJKO: We will now commence the
2	official record of the local hearing. The Public
3	Utilities Commission of Ohio has assigned a
4	public hearing at this time and place, case
5	number 08-1094-EL-SSO, et al., being captioned in
6	the matter of the application of the Dayton
7	Power & Light Company for approval of its
8	electric security plan. Dayton Power & Light is
9	also seeking approval of revised tariffs, certain
10	accounting authority and its amended corporate
11	right.
12	As I stated before, my name is Kim
13	Bojko. I am an attorney examiner in the
14	Commission's legal department and I am one of two
15	attorney examiners assigned to the case before
16	us. Again, this is Commissioner Roberto here
17	with me today at the table. She is one of five
18	commissioners that will hear the case.
19	If you have a question concerning
20	the utility matter, other than DP&L's electric
21	security plan application that is before us,
22	which is the focus of today's hearing, commission
23	staff and the consumers' counsel will be happy,
24	I'm sure, to answer your questions.
25	I would also note that there are a

6	the commission does hear. At this time I will
7	ask counsel for the Dayton Power & Light Company
8	and the interveners that are present to make an
9	appearance.
10	MR. FARUKI: Good afternoon, again,
11	your Honor. My name is Charles Faruki on behalf
12	of DP&L. After we make appearances I can also
13	add to the record the newspapers in which notice
14	was published.
15	MS. BOJKO: All right. Mr. Reese,

3 MR. FARUKI: Yes. Thank you, your 4 Honor. In addition to the publication of notice 5 in the Dayton Daily News, which covers most of 6 Butler County, part of Champaign, and all of 7 Clark, Darke, Greene, Miami, Montgomery, Preble 8 Counties, part of Shelby County and most of 9 Warren County, notice was published in the 10 following newspapers: In Champaign County in the 11 Daily Citizen, in Clinton County in the News 12 Journal, in Fayette County in the Record Herald, 13 in Greene County in the Xenia Daily Gazette, 14Logan County in the Bellfontaine Examiner, and 15 Mercer County in the Daily Standard, in Miami 16 County in the Troy Dialy News, Shelby County in 17 the Sidney Daily News, and Warren County in the 18 Western Star. I just wanted to make that of 19 record. 20 MS. BOJKO: On October 10, 2008,

Dayton Power & Light filed applications with the
PUCO to establish a standard service offer for
retail electric services, and that was based on
an electric security plan. I think you've heard
this today called an ESP, Electric Security Plan.

1	And the local public hearings are only one aspect
2	of the case process. There was an evidentiary
3	hearing in Columbus on February 11, 2009, and it
4	was continued until February 24, 2009.
5	The purpose of an evidentiary
б	hearing is to allow DP&L interveners and the
7	commission staff to present expert witnesses and
8	evidence in support of their positions in the
9	case. And at the evidentiary hearing on the
10	24th, earlier this week, as Mr. Butler stated, a
11	stipulation and recommendation was submitted to
12	the commission for consideration. The agreement
13	was executed by 15 parties in the case.
14	In addition to the hearing today, I
15	would like to note that there are two other local
16	public hearings scheduled, one this evening and
17	one next week on March 4. The purpose is to
18	receive comments from the public regarding DP&L's
19	application. We will not be hearing from the
20	companies today. We will not be hearing from the
21	commission staff or the interveners today. This
22	is your opportunity to let the commission, and
23	one commissioner in particular that is here today
24	with us, to let her know and all the other
25	commissioners what you think about the company's

2	And when you arrived, you were given
3	the opportunity to sign up on the sign-in sheet
4	stating that you wish to testify. Now, if you
5	missed that opportunity, it's not too late. You

7	believe she's out in the hall or standing in the
8	back of the room, and they would be happy to sign
9	you up. You have to put your name and address.
10	And then we will take the witnesses in the order
11	in which they signed up.
12	I will begin calling each witness
13	who wishes to make a statement on the record to
14	come forward. Before you begin your statement,
15	I'd ask for your name and address; and you will
16	be required to take an oath or affirm stating
17	that what you are about to say is the truth or
18	what you're saying is the truth. And your
19	testimony will be considered a part of the
20	official record.
21	As you can see, we have a court
22	reporter here who is taking down your testimony
23	in a typewritten fashion. And should you decide
24	that you do not want to testify and you've

14	that's none of my business or whatever.
15	The customer service at DP&L has
16	changed over the years drastically in the last 10
17	or 12 years. One of the questions that I have
18	with DP&L is the outages that occur at my house
19	on Hedgegate. In May and June we had between
20	eight and ten outages that I had DP&L on. They
21	finally gave me a name of a person the PUCO
22	gave me a name of the person to call in their
23	corporate office, I guess, higher up, supposed to
24	be, customer service, which she did not feel
25	after September 14 she did not feel she even had

1	to answer the phone because I haven't heard from
2	her. I've left numerous messages for her and she
3	has not even returned the calls.
4	We used to live on Entrada, 3408
5	East Entrada Drive. It is right on the border
6	between Montgomery and Greene County. Mind you,
7	both these houses had buried transmission lines,
8	so they shouldn't have had problems other than
9	what was outside of the area. And one of the
10	reasons why, you know, we moved in both of these
11	houses is because of the buried transmission
12	lines. They said, you won't have problems with
13	outages near as much. Boy, oh, boy, have we.
14	We have been at Entrada my
15	daughter owns a house now. They were out of
16	power numerous times there where it comes into
17	Greene County there's a couple of houses there
18	that are hooked up to the Montgomery County side
19	of the line. The pole is right on Montgomery
20	County and it goes it is actually the
21	development.
22	And, you know, this maintenance. If
23	you drive up and down Kemp Road or Burkhart,
24	drive up and down lanes, you drive up and down
25	not North Fairfield, into the city of Dayton on

	Burkhart, you see poles that are banana shaped.
2	There's lines directly or trees laying
3	directly on lines. They used to come out and do
4	maintenance on these things about once a year it
5	seemed like; and some of these I don't think
6	they've done maintenance on in five or ten years
7	on these trees.
8	Also, used to see them replace
9	poles. I haven't seen them replacing poles
10	there, unless one of them was hit by a car, in
11	years. I told you about the outages in June,
12	September. How much do we have to pay for as a
13	consumer? As Robert Forrester stuff with the
14	the investments that he made for DP&L and the
15	losses that he had and in the litigation and
16	settlements and lawyer fees and everything. Is
17	this actually coming out of the consumers'
18	pockets in the bill paying where DP&L had to I
19	believe it was not quite a hundred million
20	dollars. It was ten million and a hundred
21	million dollars what they paid, for Robert
22	Forrester and his cohorts to get out of the
23	litigation.
24	Who's paying for this actually?
25	What happened to all the money that was invested?

1	These are just some questions. Okay. Then
2	another thing, they said they needed a rate
3	increase. It was in the paper reported that they
4	needed a rate increase because of power outages
5	on September 14 and how they had to hire in extra
6	help to come and do it to come and take care
7	of it and they weren't using their people. I
8	also noticed in the paper they said they sent
9	their people down South prior to that to take
10	care of it. The money that was derived from
11	that, shouldn't that pay for the people they had
12	to hire up here?
13	It's just some concerns that I've
14	had over the years. I do have the names of the
15	people at home that I've talked with at the PUCO.
16	Mind you, they've been very, very cooperative,
17	very, very polite and so forth. Can't say as
18	much about DP&L people. That's all I have.
