



MEMORANDUM IN SUPPORT

I. INTRODUCTION

This action arises out of Odessa and David Henderson's ("Complainants") complaint against The Cleveland Electric Illuminating Company ("CEI") filed on September 12, 2008. In paragraph 5 of the Complaint, Complainants alleged that Gregory Giles and Jan Parks (collectively "Giles/Parks") resided at 885 Keystone Drive during the period in which the amounts included in the disputed bill arose and that said individuals were willing to enter into a payment plan to pay the outstanding arrearage. The Company, after numerous attempts, finally contacted Jan Parks, who reiterated that Giles/Parks consumed the electricity during the period in question and that they were willing to set up a payment plan. However, since that conversation, Jan Parks has failed to return telephone calls from CEI's counsel, or to follow through on setting up a meeting with CEI's counsel so as to settle this matter.

On October 31, 2008, The Cleveland Electric Illuminating Company timely filed its answer to the complaint. On November 5, 2008, CEI also filed a motion requesting the Commission to join Jan Parks and Gregory Giles to the proceeding in order to properly resolve the matter and hold the proper party responsible for payment of the electricity consumed at the location in question. That motion was denied by Entry issued February 9, 2009. However, in this same entry, the Commission noted that CEI could subpoena Jan Parks and Gregory Giles (Entry at 2), thus prompting the instant request.

II. ARGUMENT

Section 4901-1-25(A) of the Ohio Administrative Code provides, "The commission, any commissioner, the legal director, or the attorney examiner assigned to a case may issue subpoenas, ... upon motion of any party. A subpoena shall command the person to whom it is directed to attend and give testimony at the time and place specified therein." Therefore, in


accordance with the Ohio Administrative Code, The Cleveland Electric Illuminating Company respectfully requests the Commission to issue the attached subpoena requiring Greg Giles to appear as a witness in the hearing on this matter, which is scheduled on May 28, 2009 at 11:00 AM in Room 11-G of the Commission's offices, 180 East Broad Street, Columbus, Ohio 43215-3793.¹

While CEI believes that it has sufficient grounds to charge the Complainants for the usage during the period in question, CEI would prefer to charge the consuming party. In order to formally determine the identity of such individual(s), the attendance of Mr. Giles is necessary.

III. SUMMARY AND CONCLUSION

Based upon the foregoing, CEI respectfully asks that the Commission issue the attached subpoena compelling the attendance of Mr. Greg Giles at the scheduled evidentiary hearing in this matter. Further, CEI requests waiver of the deposit of witness fees, instead committing to pay the same on the day of the hearing.
