SECTION 2.0 - REGULATIONS, (CONT'D.)**2.5 Payment Arrangements****2.5.2 Billing and Collection of Charges**

Bills will be rendered monthly to Customer. The Company's bills and billing practices will comply with Minimum Telephone Service Standards as codified Chapter 4901:1-5 of the Ohio Administrative Code.

A. Late Payment

Amounts not paid within thirty (30) days after the date of the invoice, but no sooner than nineteen (19) days after the postmark on the bill, are considered past due, and a late payment penalty shall be due the Company. The late payment penalty shall be \$5.00 or that portion of the payment of regulated charges not received by the due date minus any charges billed as local taxes, multiplied by 1.5%, whichever is greater. (C)
Late fees will not be applied to disputed charges, service establishment charges for Lifeline services and will not be assessed on any previous late fees included in the amount due. (I)
