Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 1011 – Effective May 23, 2009
With this transmittal, Verizon is revising FCC No. 14 to introduce a new contract tariff option that provides Quarterly Billing Credits on Special Access High Capacity 1.544 Mbps (DS1) Services, and multiplexed and point-to-point 44.736 Mbps (DS3) Services and other benefits to customers who meet certain eligibility requirements and other requirements as specified in the new contract tariff option.

8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

This filing is issued under authority of Special Permission No. 09-007 of the Federal Communications Commission. Verizon is submitting tariff pages to introduce a new contract tariff option in its Access Service Tariffs FCC Nos. 1 (FCC 1) and 11 (FCC 11), and its Facilities for Interstate Access Service Tariff FCC No. 14 (FCC 14). The new contract tariff option provides Quarterly Billing Credits on Special Access High Capacity 1.544 Mbps (DS1) Services, and multiplexed and point-to-point 44.736 Mbps (DS3) Services and other benefits to customers who meet certain eligibility requirements and other requirements as specified in the new contract tariff option. This new contract tariff option is being filed in FCC 1, FCC 11, and FCC 14 where Verizon has received Pricing Flexibility relief for Special Access Services in Qualifying Metropolitan Statistical Areas.
