

This Supplemental Subpoena supplements the first Qwest subpoena filed by Global NAPs Ohio, Inc. ("Global NAPs") in this docket on February 26, 2009 ("First Qwest Subpoena").


You shall bring the following:

1. The Customer who transfers the call to Qwest and the Customer to whom Qwest transfers the call upon terminating each call;
2. The structure and elements of charges by Qwest to the Customers, if any, and the structure and elements of charges by the Wholesale Customers to Qwest, if any; and
3. The portions (redacting pricing, although not redacting structure and rate elements) of any agreements between Qwest and the Customer who transfers the call to Qwest and the Customer to whom Qwest transfers the call relating to Qwest's provision of 1+ originating toll carriage.


