MOTION TO WITHDRAW COMPLAINT


Now comes Britney Bruce who, through counsel, hereby moves to withdraw her complaint in the above captioned matter.

On March 6, 2009, Britney Bruce (complainant) filed a complaint with the Commission against East Ohio Gas Company d/b/a Dominion East Ohio (Dominion). A settlement conference was scheduled in the matter for April 28th, 2009. At the request of counsel for Ms. Bruce, the scheduled conference was held in abeyance while counsel attempted to contact Ms. Bruce.

Since the filing of this Complaint, Ms. Bruce has refused to cooperate with her counsel in continuing to prosecute the matter. Counsel has been unable to contact Ms. Bruce for over a month. Due to this lack of cooperation and contact by Ms.




