Nexus is a Facilities-Based C.M.R.S. provider using a combination of its own facilities and interconnected services of another carrier. Nexus's SIP based co-located facilities interconnect with Nexus' underlying carriers via VoIP technology and a combination of SIP trucking and IP-PBX. Session Initiation Protocol (SIP) or Virtual Trunking is a signaling protocol utilized by multi-mode carriers like Nexus in lieu of PRI or analog circuits. Consistent with Section 214(e)(1)(A) of the Commissions Act and 47 C.F.R. § 54.201(d) of the FCC's rules, Nexus is a Facilities-Based telecommunication provider which uses a combination of its own facilities and interconnected services of another carrier.
