AFFIDAVIT OF ELLEN E. REGENNITTER

Ellen Regennitter, upon her oath, deposes and states:

1. I am employed by American Electric Power Service Corporation (AEPSC), a wholly owned subsidiary of American Electric Power Company, Inc. (AEP). AEP is the parent company of Columbus Southern Power Company (CSP). I am employed as an Engineer III. In that capacity, I am responsible for and involved in the preparation and oversight of transmission projects like the pending Roberts-OSU 138kV transmission line project.

2. I have personal knowledge of the details of CSP's documentation concerning the preferred route for the proposed project in this docket and the application filed in this case.

3. I would like to clear up a misperception from the public hearing and found in a letter submitted in the docket in this case. There is a concern that the preferred route will impact certain properties on the north side of Dublin Road. In fact, the route being requested as the preferred route in this area runs along the already existing right-of-way on the south side, across from these properties. There should be no clearing of mature trees on the north side of Dublin Road near these addresses in relation to the building of this transmission project.
