The attorney examiner finds:

- (1) Commission staff has served a notice of preliminary determination upon (respondent) in accordance with Rule 4901:2-7-12, Ohio Administrative Code (O.A.C.), alleging violations of the Commission's transportation regulations.
- (2) Respondent has filed a request for an administrative hearing in the above-captioned case in accordance with Rule 4901:2-7-13, O.A.C.
- (3) As set forth in Rule 4901:2-7-16(B), O.A.C., unless otherwise ordered by the Commission or agreed by the parties, a prehearing conference in a civil forfeiture case shall be scheduled within 30 days of the filing of a request for administrative hearing.
- (4) Because the Commission desired to further review matters associated with civil forfeiture cases, the prehearing conference for this case was postponed until a date to be scheduled by entry.
- (5) The parties in this case are directed to participate in a prehearing teleconference on September 22, 2009, at 10:00 a.m., Eastern Daylight Time. At that time, Commission staff will attempt to contact respondent by telephone.
