## BP HUSKY REFINING, LLC's MOTION FOR A WAIVER OF OHIO POWER SITING BOARD RULES

## I. MOTION FOR WAIVER

BP Husky Refining, LLC ("BP-Husky") moves the Power Siting Board pursuant to Rule 4906-1-03, O.A.C., for a waiver of the following provisions of the Board's statutes and regulations:

- The requirements of Section 4906.06(A) that an application for certificate for construction of transmission facilities be filed not less than one year prior to the planned date of commencement of construction.
- 2. The requirements of Section 4906-15-07(E) that a review of the existing vegetation must occur for the alternative sites.
- 3. The requirements of Section 4906-15-06 (F) that a review of the impacts on cultural resources must occur for the alternate sites.

II. MEMORANDUM IN SUPPORT

1. Waiver of the Pre-construction Notice Period

Section 4906.06(A) permits waiver of the one-year notice requirement for new transmission

facilities for unforeseen emergencies. The Applicant requests waiver of this requirement in order to

permit construction of the substation project to commence immediately following issuance of a

certificate of environmental compatibility and public need in this proceeding. This construction

schedule is necessary in order to ensure that the project is in service to meet the needs of the more

efficient Reformer 3.

2. Waiver of the Wetlands review of the Alternate Site

The Preferred and Alternate sites are very close in proximity. Desktop surveys and visits to the

site have indicated that there are no wetlands present at the Alternate Site. Therefore no individual

wetland survey was completed for the Alternate Site.

3. Waiver of the Cultural review for the Alternate Site

The Preferred and Alternate sites are very close in proximity. Desktop reviews cover the

required area for both sites. An on-site review was not conducted for the Alternate Site due to the

Desktop review indicating no presence of historic sites.
