The organizations and their representatives included: The Office of the Ohio Consumers' Counsel (Janine Migden-Ostrander, Bruce Weston, Wilson Gonzalez, and Greg Poulos), the Ohio Environmental Council (Nolan Moser and Will Reisinger), Environment Ohio (Amy Gomberg and Amanda Moore), the Ohio Poverty Law Center (Joseph Maskovyak), Sierra Club (Ned Ford), Citizen Power (Ted Robinson), and the Northwest Ohio Aggregation Coalition (Lance Keiffer).

During the meeting representatives for OCEA addressed Ohio Administrative Code Chapters 4901:5, 4901:1-39, 4901:1-40. The representatives for OCEA discussed how the rules currently approved by the PUCO are consistent with the intent of Ohio law and the Commission's statutory rulemaking authority.
