On September 22, 2009, seven organizations that are part of the Ohio Consumer and Environmental Advocates ("OCEA") met with Chairman Schriber and Commissioner Roberto of the Public Utilities Commission of Ohio ("PUCO" or "Commission") at the Office of the Ohio Consumers' Counsel, 10 West Broad Street, Columbus, Ohio, to discuss the rules adopted in this proceeding. The organizations and their representatives included: The Office of the Ohio Consumers' Counsel (Janine Migden-Ostrander, Bruce Weston, Wilson Gonzalez, and Greg Poulos), the Ohio Environmental Council (Nolan Moser and Will Reisinger), Environment Ohio (Amy Gomberg and Amanda Moore), the Ohio Poverty Law Center (Joseph Maskovyak), Sierra Club (Ned Ford), Citizen Power (Ted Robinson), and the Northwest Ohio Aggregation Coalition (Lance Keiffer).

During the meeting representatives for OCEA addressed Ohio Administrative Code Chapters 4901:5, 4901:1-39, 4901:1-40. The representatives for OCEA discussed how the rules currently approved by the PUCO are consistent with the intent of Ohio law and the Commission's statutory rulemaking authority.

Per Ohio Administrative Code 4901-1-09: "Any participant in the discussion who believes that any representation made in this document is inaccurate or that the communications made during the discussion have not been fully disclosed shall prepare a letter explaining the participant's disagreement with the document and shall file the letter with the Commission and serve the letter upon all parties and participants in the discussion within two business days of receipt of this document."
