NOTIFICATION OF MATERIAL CHANGE


Rule 4901:1-27-10(A), Ohio Administrative Code ("OAC") requires that retail natural gas suppliers file with the Commission a notification of any material change to the information supplied in a certification or most recent certification renewal application within thirty days of such material change. Rule 4901:1-27-10(B)(9), OAC, specifically defines "material change" as including "any use of a fictitious name."

Pursuant to Rule 4901:1-27-10(A), OAC, Dominion Retail hereby provides notice to the the Commission that it has registered the additional fictitious name of "Dominion Energy Solutions" with the Ohio Secretary of State. A copy of the certificate issued by the Ohio Secretary of State in the name of "Dominion Energy Solutions" is attached hereto as Exhibit A. Thus, in the future, Dominion Retail may offer service under any or all of the names "Dominion Retail," "Dominion East Ohio Energy," or "Dominion Energy Solutions."
