

FOR NATURAL GAS SERVICE**


Piedmont Gas Company ("Piedmont" or "PGC") is a public utility and a natural gas company subject to the jurisdiction of this Commission pursuant to Sections 4905.02 and 4905.03(A)(6), Revised Code. PGC provides natural gas service to approximately 1,700 customers located in Tuscarawas, Coshocton, Harrison, Guernsey, and Holmes Counties, Ohio. All customers have been served pursuant to a tariff established in 1994. Piedmont has never filed a rate increase application.

Pursuant to Chapter 1, Section B of the Commission's Standard Filing Requirements (Rule 4901-7-01 of the Ohio Administrative Code, Appendix) Piedmont hereby submits its pre-filing notice ("PFN") of its intent to file an application for an increase in rates and charges for natural gas service to customers throughout its service area. As part of this notice, PGC moves for approval of a test year consisting of the twelve (12) months ended December 31, 2008 and a date certain of December 31, 2008. Pursuant to Chapter 1, Section B of the Standard Filing

Requirements, the following exhibits are attached hereto:

- (a) PFN Exhibit 1: statement of notice of intent to file for an Increase in rates the service area to be included in the application; and a proposed test year and date certain;
- (b) PFN Exhibit 2: Listing of the village and the Mayor and legislative authority to whom notices of intent were sent pursuant to Section 4909.43(B), Revised Code;
- (c) PFN Exhibit 3: The proposed rates that are intended to replace or amend the current rates;
- (d) PFN Exhibit 4: Typical bill comparisons for each customer class.

**NOTICE OF INTENT OF PIEDMONT GAS COMPANY
TO FILE AN APPLICATION FOR AN INCREASE IN RATES
AND CHARGES FOR NATURAL GAS SERVICE**

Piedmont Gas Company ("Piedmont" or "PGC") intends to file an application with the Public Utilities Commission of Ohio ("PUCO") for an increase in the rates and charges for natural gas service to all customers throughout its service area. PGC's current rates were established in 1994 when its rates were unbundled. The purpose of PGC's rate increase application will be to provide Piedmont with an opportunity to recover the cost of providing service and to earn a fair and reasonable return on its investment in property used to provide such service.

Therefore, in accordance with the requirements of Section 4909.18 and 4909.43(B), Revised Code, Piedmont hereby serves it notice of intent to file an application for an increase in rates and charges for natural gas service with the PUCO. PGC proposes that the test year for the analysis of accounts be the twelve (12) months ending December 31, 2008 and that the date certain for the valuation of its property be established as December 31, 2008. In compliance with Chapter I, Section A of the PUCO's Standard Filing Requirements, the rates to be proposed in the application are attached hereto as Exhibit PFN 3.
