I am writing you concerning the Public Utilities Commission of Ohio, Case No. 09-68-RR-FED, and authorization of the Indiana & Ohio Railway to install an Active Grade Crossing Warning Devices at the below designated locations as ordered.

 (IORY) - West Main Street - Warren County - DOT# 525235M - PUCO No. 09-68-RR-FED - ORDC Enc. No. 571600 (ORDC Construction Authorization filed: June 1, 2009, PUCO Ordered Due Date: February 4, 2010)

The PUCO Order for the subject crossings requires the above listed projects to be in-service by February 2, 2010. The ORDC provided Construction Authorization filed June 1, 2009.

However, the City of Mason has notified the IORY that the Roadway Contractor will not begin road construction until early spring, 2010 (see attached documentation).

The IORY formally requests an extension of the PUCO Order due date from February 4, 2010, to August 4, 2010 in order to allow Roadway Construction to progress to the necessary stage for the IORY to facilitate the proper installation of the new warning system at the West Main Street railroad crossing.

Construction of the Mason Road Widening from West Main Street to West Corporation Line and West Main Street from Forest Avenue to Mason Road started on Monday, August 10, 2009. Trend Construction, the contractor on this project started on the 12" water main replacement in West Main Street. Duke Energy started to replace electric poles in September. Contractor plans to continue to work on storm sewer relocation and water main work through the end of the year.

Contractor plans to start road construction in early spring 2010.
