

Dear Ms. Dalton:

On May 18, 2009 CSX Transportation, Inc. ("CSXT") requested an extension of the construction due date for the subject project to December 4, 2009. The Public Utilities Commission of Ohio ("PUCO") granted the extension on June 10, 2009. The extension was requested due to the time lapse in retrieving sidewalk / roadway plans and cost estimates from the Village of Bradner (the "Village").

The improvements at Crocker Street, per the Subsidy Agreement, were to (i) widen the road not to exceed 60 feet, (ii) install a new concrete surface, and (iii) relocate the flashers accordingly. CSXT could not to proceed with our work without details of the Village's planned improvements at Crocker Street, including details on the widening.

The Subsidy Agreement also included language for the Village to install barricades and curbs due to the related closure of Lightner Street, with CSXT to reimburse the Village for the costs. CSXT requested estimates for the barricades and curbs on several occasions. The quotes for the barricades were finally received from the Village on October 7, 2009. Force Account Estimates for the project were submitted to ORDC on October 9, 2009. CSXT anticipates receiving construction authorization from ORDC in the near future.

Once construction is authorized, the signal work can begin, but winter weather will delay the installation of the new concrete surfaces because of the necessary asphalt paving of the vehicular approaches.
