Effective cycle 1 January, 2005, all customer bills subject to the provisions of this Rider, including any bills rendered under special contract, shall be adjusted by the Universal Service Fund charge of 0.04650¢/KWH for the first 833,000 KWH consumed each month and 0.01681¢/KWH for all KWH consumed each month in excess of 833,000 KWH.

This Rider shall remain in effect until no later than December 31, 2008.
