**APPLICATION OF CHRISTI WATER SYSTEM, INC. FOR  
AN ADJUSTMENT TO ITS PURCHASED WATER RATES**

Pursuant to Ohio Revised Code Section 4909.171, Christi Water System, Inc. ("Christi") is hereby submitting to the Public Utilities Commission of Ohio ("Commission") notice of an increase in rates by the City of Defiance ("City") for the water supplied to Christi. The City's water operation, which does not fall under the jurisdiction of the Commission, is the sole source of supply for Christi. Pursuant to Ohio Revised Code Section 4909.171, this Application reflects an increase imposed by the City that takes effect January 1, 2010 for which Christi Water System, Inc. has applied for an increase from the Commission.

This Application contains the following materials:

Exhibit A: A copy of the ordinance rates approved by the City on February 28, 2006 that takes effect on January 1, 2010.

Exhibit B: Calculation of adjusted purchased water rates based on the ordinance rates.

Exhibit C: Supporting data including customer usage, usage per block, revenue per block, and total water sold.

Exhibit D: Current tariff sheets reflecting the Finding and Order in Case No. 09-237-WW-PWA, in which the Commission approved an adjustment in the purchased water rate with current rates.

Exhibit E: New tariff sheets, whose rates reflect only the increase in rates imposed by the City with proposed new rates.

Exhibit F: A customer notice to be distributed to each customer prior to the effective date of the new rates.

As mentioned above, the new rates reflect only the increase in rates experienced by Christi as a result of the increase in the wholesale water rates imposed on Christi by the City.

## Ordinance No. 6657

### AN ORDINANCE AMENDING SECTION 921.03 OF THE CODIFIED ORDINANCES ESTABLISHING THE RATES TO BE CHARGED FOR WATER FURNISHED BY THE CITY FROM AND AFTER APRIL 1, 2006, AND DECLARING AN EMERGENCY

WHEREAS, revenues generated by the sale of water are insufficient to support the operation and maintenance of the Water Treatment Works; and,

WHEREAS, it is necessary to construct a water reservoir to safeguard the public from nitrates and other contaminants found in raw water drawn from the Maumee River and to comply with regulatory requirements of the Ohio Environmental Protection Agency; and,

WHEREAS, revenues presently generated from the sale of water are insufficient to service the debt to be incurred for construction of the necessary reservoir;

Now therefore, be it enacted by the Council of the Municipality of Defiance, Ohio, that:

**Section 1:** The cost rate schedule for metered water furnished to properties within the corporate limits of the City and for which invoices are issued during the following periods shall be:

**Section 6:** Ordinance 5870 shall remain in full force and effect and nothing contained in this Ordinance shall be deemed to affect any amendment or repeal of the rates therein established or to impair the collection of any obligation incurred under Codified Ordinance 921.03 prior to April 1, 2006. The Walker H. Drane Company is, however, directed to limit the content of Codified Ordinance 921.03 to the effective dates and rates established by this Ordinance in future publications of Codified Ordinance 921.03.

**Section 7:** It is found and determined that all legislative actions pertaining to the adoption of this Ordinance were taken in Public Session and that all deliberations that affected or influenced any such legislative act, including all deliberations in Committee, were conducted in Public Session or in Executive Session duly convened in accordance with law.

**Section 8:** This Ordinance is declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community for the reason that immediate implementation of the water rates established by this Ordinance is necessary to preserve the solvency of the Municipal Water Works and achieve compliance with regulatory obligations. As such, this Ordinance shall be effective immediately upon passage by a 3/4<sup>th</sup> majority of Council and approval of the Mayor.

## CALCULATION OF ADJUSTED PURCHASED WATER RATES

**CHRISTI WATER SYSTEM, INC.**

Case No. \_\_\_\_ - \_\_\_\_ -WW-PWA

Christi Water's current rate structure is a 3 declining block rate structure, with base rates and purchased water rates separated to facilitate the adjustment of purchased water rates when rate changes are imposed on Christi Water by its bulk water supplier, the City of Defiance. Current rates are as follows:

<u>Usage Bracket</u>	<u>Base Rate</u>	<u>Purchased Water Rate</u>

To determine the Purchased Water Adjustment (PWA) the procedure shown on the attached worksheet was developed and applied in Case No. 95-986-WW-PWA to calculate the percent of increase or decrease of customer rates.

1. Based on the average monthly usage for the previous year, calculate the annual purchased water billing from the supplier, including applicable taxes, using both old and new rates.
2. Calculate the percent increase in Christi's purchased water expense.
3. Calculate proposed purchased water rates by applying the same percent increase to each of the three declining block rate groups.
4. Using the proposed purchased water rates, calculate the proposed purchased water revenue.
5. Verify that the proposed purchased water revenue equals the new purchased water expense.

### Dear Christi Water Customer:

Ohio Revised Code Section 4909.171 provides that when a water company, such as Christi Water, under the jurisdiction of the Public Utilities Commission of Ohio receives its water supply from a municipal corporation or other local government unit, such as the City of Defiance, it may change its rates to reflect either increases or decreases in rates imposed on it by the municipal corporation or other local government unit, after it has given notice of the change to the Commission. This procedure saves Christi Water customers from bearing the expense of a rate case whenever the City changes its rates to Christi Water.

On February 28, 2006, the City of Defiance passed an ordinance which provides for an increase in rates each year for 5 years to Christi Water with the fourth change effective January 1, 2010. New rates to our customers will become effective \_\_\_\_\_, 2010. The new Christi Water rate represents only the change in the rates from the City of Defiance. No other costs of Christi Water have been figured into the rates. Should Christi Water wish to have other costs reflected in its rates, such as an increase in taxes or an addition to plant, it will be required to file an application for an increase in rates, for which the traditional ratemaking procedures, including a local public hearing, will be scheduled. Christi Water has filed an application for a base rate increase that is pending before the commission for consideration and may increase your rates in the future for the generation of revenue to pay for maintenance of the main lines etc. This current increase is to cover only the purchased water used by customers.

Below is a comparison of the current rates and the new rates as a result of the increase from the City:
