How is the community able to choose a certified electric generation supplier on my behalf? The residents of your community voted to allow your local government officials to contract for an electric generation supplier on their behalf.

#### What does "opt out" mean?

"Opt out" means that you can decide not to participate in the community's electric governmental aggregation program.
