On January the 25th or 26th 2009, an Ohio Edison crew pulled the meter off my property. Which in doing, they broke the left top pole in the meter base. They also cut the power supply lines at the top of their pole. This shut the power off to my property leaving it to freeze up. There was twelve to sixteen inches of snow and ice on the ground and the temperature was in the single digits.

Ohio Edison has accused me of tampering with their meter and stealing their power. I have done no such thing. I have explained this to them but they still insist that I pay penalties and fraud investigation fees. To do so, would be to admit that their allegations are true. I will not admit to what I did not do.

I have sent Ohio Edison the facts regarding this matter. First a fax sent to their number 1-330-315-9277. Then after waiting two weeks for a return, I called their 1-800 number once again. I ask if they had received the fax, I was told that they had not. I then ask for an address to which I could send the information once again via certified mail. This I did. Still, I waited weeks and no response from Ohio Edison, I then E-MAILED the PUCO. The confirmation number of this E-Mail is WEBID43735. About a week later I got a call from a lady who identified herself only as Tara. She took the side of the Ohio Edison and told me that the only way that I was going to get power restored was to pay the fines and fraud charges. I told her that I would pay only what anyone else would pay to obtain power and I was not about to admit tampering and theft by paying fines and fraud investigation fees. She offered no further advise as to my next step.

I have not heard from Ohio Edison in any way. Still have no power to my property. It has been more than a year.

Ohio Edison has violated the law by pulling the meter from my property in the dead of winter. Causing me much property damage.

Ohio Edison has called me a thief.

Ohio Edison has refused to correspond with me.

I want the power restored to my property. I want to be made whole for the damages done to my property. I want punitive damages for the arrogance of those that have caused me this grief.
