

NOTICE OF THE OHIO SCHOOLS COUNCIL

On December 15, 2009, FirstEnergy filed an Application for approval of its: 1) initial three-year energy efficiency and peak demand reduction program portfolio; and 2) initial compliance report with the energy efficiency and peak demand benchmarks set forth in Amended Senate Bill 221. The Ohio Schools Council (“OSC”) filed a Motion to Intervene on January 15, 2010 that remains pending. At the evidentiary hearing in this matter, the Attorney Examiner set a procedural schedule and invited interested parties to submit initial briefs by March 29, 2010 and reply briefs by April 12, 2010.

OSC hereby gives notice that it will not file an initial brief in the above-captioned proceedings. OSC does, however, reserve the right to file a reply brief.


