**A RESOLUTION
COMMENDING THE OHIO PUCO FOR RESTORING AND URGING
FIRST ENERGY TO MAINTAIN DISCOUNTS FOR ALL-ELECTRIC
HOMES**

WHEREAS, on or about June 7, 2007, FirstEnergy filed an application to increase the rates it charges for electric distribution service, and thereafter an increase was granted by the Ohio Public Utilities Commission on January 21, 2009; and

WHEREAS, the effects of such increase on customers who were previously on one of the "all-electric" rates are actually greater notwithstanding the FirstEnergy electric security plan and the Ohio Legislature's passage of Senate Bill 221; and

WHEREAS, under FirstEnergy's Rate Certainty Plan (RCP) approved by the PUCO in January, 2006, customers were expected to pay essentially the same prices for electricity through 2008 as they had paid in the mid-1990's; and

WHEREAS, the RCP also included a provision that special electric heating, water heating and load management rates would no longer be available to new customers or new premises beginning January 1, 2007; and

WHEREAS, as part of the RCP, existing customers were to be "grandfathered" continuing to receive the preferential rates as long as they continued to live in their home and the rate was in effect; however, in 2009 these "grandfathered" rates have been eliminated; and

WHEREAS, the Ohio PUCO has restored the all-electric home discount but FirstEnergy has not given up its efforts to eliminate the all-electric home discount.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Mayor and this Council commend the Ohio PUCO for restoring the all-electric home discount and urge FirstEnergy stop its efforts to eliminate the all-electric home discount.

Section 2: That the Clerk of Council is hereby authorized and directed to certify copies of this Resolution to Governor Ted Strickland, to State Senator Dale Miller and State Representative Timothy DeGeeter, as well as to the Public Utilities Commission of Ohio, Ohio Consumers' Counsel and to FirstEnergy's Corporate Headquarters.



Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of
