The Self Direct Prescriptive project that Abercrombie and Fitch has completed and applied is as follows. It is the replacement of (400) 400 watt HID lighting fixtures with (400) 4-lamp T5/4' general lighting fixtures, (245) 400 watt HID lighting fixtures with (245) 4 lamp T5/4' aisle lighting fixtures, and (225) T12/4' to (225) T8/4' lighting fixtures. The documentation that was included with the application proved that the energy measures applied for were purchased and installed.

By signing this document, the Mercantile customer affirms its intention to commit and integrate the above listed demand reduction, response, and/or energy efficiency resources into the utility's demand reduction, demand response, and energy efficiency programs.
