Dear Ms. Jenkins:

AT&T Ohio and United Telephone Company of Ohio d/b/a CenturyLINK (the "Joint Applicants") hereby file a revised map for the Holland exchange of AT&T Ohio and the Swanton exchange of CenturyLINK without application, pursuant to Ohio Administrative Code §4901:1-6-20. Both this letter and the revised quadrangle map is being filed pursuant to Ohio Administrative Code §4901:1-6-20.

The revised map reflects the incorporation of a small portion of CenturyLINK's Swanton exchange into the Holland exchange of AT&T Ohio. This is an administrative change only, made to reflect the current serving arrangements that have been in place for a number of years.

This boundary change affects an area located at the Toledo Express Airport by the sewage disposal facility. The new boundary dimensions follow: 150' South of R/W Airport Hwy. West approximately 5,750', 150' East of R/W Berkey-Southern Route 295. South approximately 2500', East approximately 3500', South approximately 1,000', East approximately 1250'.

The Joint Applicants are in concurrence with this change, and confirm that this change will not adversely affect the service being furnished to any existing subscriber. AT&T Ohio serves the customers today in the affected area.
