On April 6, 2010, CenturyTel Operating Companies filed Transmittal No. 77 with the Federal Communications Commission. The revisions made to Tariff F.C.C. No. 1 will become effective April 21, 2010. In this filing, CenturyLink proposed the following housekeeping revisions to Tariff F.C.C. No. 1:



- 4) Removed obsolete references to Metallic services since this service has been removed from the tariff;


- 5) Section 12 has been revised to reflect regulations for Specialized Services or Arrangements; and

In addition, corrections are made to the Presubscribed Interexchange Carrier (PIC) Change Charge currently shown in CenturyTel Operating Companies Tariff F.C.C. No. 7 to reflect the correct rates on the tariff page, rather than the reference of "ICB" for the nonrecurring charge. It should be noted that all of the revisions proposed in this filing are housekeeping in nature and will not impact customers.
