
Re: PUCO Case No. 10-176-EL-ATA (All electric rates)

Dear Ms. Jenkins:

The Public Utilities Commission of Ohio ("PUCO") has a rule that requires disclosure of certain communications between a party to a pending case and a PUCO Commissioner. Accordingly, here is a disclosure regarding a meeting that occurred on May 12, 2010, at the Office of the Governor. Attending the meeting were the following members of Citizens for Keeping the All-Electric Promise ("CKAP"), a coalition of all-electric homeowners in Northern Ohio: Sue Steigerwald, Michael Carney, Kevin Corcoran, Rita Lockhart, and Rich Jordan. The meeting was also attended by the following members of the PUCO: Chairman Alan Schriber, Beth Trombold, and Jade Davis. Additionally, Jennifer Lynch, Sylvia Brown, Representative Lorraine Fende (and a constituent), and legislative aide Emily Tucker attended. Amy Gomberg of the Office of the Ohio Consumers' Counsel was invited to attend by CKAP and did so without offering any comments (and without knowing in advance that the PUCO Chairman would be attending). The discussion involved the concerns of the all-electric homeowners with respect to FirstEnergy's modifications to their electricity rates.

Ohio Administrative Code 4901-1-09 requires the inclusion of the following statement in this document: "Any participant in the discussion who believes that any representation made in this document is inaccurate or that the communications made during the discussion have not been fully disclosed shall prepare a letter explaining the participant's disagreement with the document and shall file the letter with the commission and serve the letter upon all parties and participants in the discussion within two business days of receipt of this document."


