**JOINT MOTION FOR CONTINUANCE OF SETTLEMENT CONFERENCE**

Pursuant to Rule 4901-1-13 and other applicable law, Complainant W. Hobart Pullins and Respondent Ohio Edison Company jointly move for a continuance of the prehearing settlement conference currently scheduled for May 27, 2010. Because of Complainant's and Respondent's counsel's conflicts with that date, which separately require Complainant and Respondent's counsel to be outside of Columbus on that day, the current date poses a hardship for both parties. 
