MEMORANDUM IN SUPPORT

By Entry of June 3, 2009, the Commission authorized the closure of the Springmill North Road grade crossing (502-669K), and the upgrading of the warning devices at two grade crossing: on Leppo Road (502-668D and 152-170N), with the closure to take place after the completion of the upgrades.

The upgrades are substantially complete – specifically, Norfolk Southern has installed its equipment, and Ashland Railway is scheduled to complete final wiring work this week, following which Norfolk Southern will complete an interconnection between its equipment and Ashland Railway's, so the warning devices can work in unison as required by MUTCD standards. Once the upgrades are operational, then Springfield Township is to install appropriate guardra is at the Springmill North Road grade crossing, to effectuate closure.

Since there are a number of players involved here, and work is substantially but not quite complete, Norfolk Southern is erring on the side of requesting an extension of time of thirty (30) days - through July 3, 2010 - for the involved parties to complete this project.
