FINDING AND ORDER

The Commission finds:

- (1) Throughout 2009 and 2010, various electric utilities and mercantile customers have filed joint applications for approval of special arrangements and exemptions from payment of energy efficiency and peak demand reduction riders.
- (2) Energy efficiency and peak demand reduction riders are the mechanisms by which electric utilities recover from customers the costs associated with compliance with the energy efficiency and demand reduction requirements set forth in Section 4928.66, Revised Code.
- (3) Rule 4901:1-39-05(G), Ohio Administrative Code (O.A.C.), authorizes a mercantile customer to file, either individually or jointly with an electric utility, an application to commit the customer's demand reduction, demand response, or energy efficiency programs for integration with the electric utility's demand reduction, demand response, and energy efficiency programs, pursuant to Section 4928.66(A)(2)(d), Revised Code.
- (4) An application filed pursuant to Rule 4901:1-39-05(G), O.A.C., shall:
 - (a) Address coordination requirements between the electric utility and the mercantile customer with regard to voluntary reductions in load by the mercantile customer, which are not part of an electric utility program, including specific communication procedures.

(b) Grant permission to the electric utility and staff to measure and verify energy savings and/or peak-demand reductions resulting from customer-sited projects and resources.

- (c) Identify all consequences of noncompliance by the customer with the terms of the commitment.
- (d) Include a copy of the formal declaration or agreement that commits the mercantile customer's programs for integration, including any requirement that the electric utility will treat the customer's information as confidential and will not disclose such information except under an appropriate protective agreement or a protective order issued by the Commission pursuant to Rule 4901-1-24, O.A.C.
- (e) Include a description of all methodologies, protocols, and practices used or proposed to be used in measuring and verifying program results, and identify and explain all deviations from any program measurement and verification guidelines that may be published by the Commission.
- (5) An application to commit a mercantile customer program for integration pursuant to Rule 4901:1-39-05, O.A.C., may also include a request for an exemption from the cost recovery mechanism set forth in Rule 4901:1-39-07, O.A.C. See Rule 4901:1-39-08, O.A.C. To be eligible for this exemption, the mercantile customer must consent to provide an annual report on the energy savings and electric utility peak-demand reductions achieved in the customer's facilities in the most recent year.
- (6) Further, under Section 4928.66, Revised Code, if a mercantile customer makes an existing or new demand response, energy efficiency, or peak demand reduction capability available to an electric utility pursuant to Section 4928.66(A)(2)(c), Revised Code, the electric utility's baseline must be adjusted to exclude the effects of all such demand-response, energy

- efficiency, or peak demand reduction programs that may have existed during the period used to establish the baseline.
- (7) On June 17, 2010, the Ohio Environmental Council (OEC) filed a motion to intervene, asserting that it has a special interest in the outcome of this case, as it seeks to ensure that the mercantile opt-out process is fair and efficient, and that all approved applications represent verifiable energy savings projects. The Office of the Ohio Consumers' Counsel also filed a motion to intervene on June 22, 2010. The Commission finds that the motions to intervene of OEC and OCC are reasonable, and should be granted.
- (8) The operating companies listed in Appendix A, attached hereto, are public utilities as defined in Section 4905.02, Revised Code, and, as such, are subject to the jurisdiction of this Commission.
- (9) The customers listed in Appendix A, attached hereto, are mercantile customers as defined in Section 4928.01(A)(19), Revised Code.
- (10) The joint applications in each of the cases listed in Appendix A request either of the following: a one-time reduced incentive payment, equal to 75 percent of the calculated incentive amount offered under the electric utility's incentive program, on the condition of continuing payment of the energy efficiency and peak demand reduction rider; or an exemption from the electric utility's energy efficiency and peak demand reduction rider for a defined period of time, as provided in Rule 4901:1-39-08, O.A.C.¹
- (11) In order to assist in the implementation of the Amended Substitute Senate Bill 221 compliance requirements and expedite the approval process for the applications listed in Appendix A, the Commission believes it is prudent to

On October 15, 2009, the Commission rejected the benchmark comparison method, reversing its prior position. Given that the agreements between the mercantile customers and the electric utilities listed in Appendix A were entered into prior to the effective date of this rule, December 10, 2009, the Commission believes that it is both equitable and reasonable to recognize the existing mercantile customer-sited capabilities and investments that relied upon the previously adopted rule's methodology.

conditionally approve each of the listed applications, subject to the Commission Staff's (Staff) review, verification, and recommendation, regarding each application and the electric utility's calculations of the savings attributable to the programs contained in the applications. As has been the case in prior application approvals, we direct Staff to continue to file its review and recommendation letter in each of the cases listed in Appendix A. Once Staff has filed its review and recommendation, any interested person wishing to object to Staff's recommendation must file an objection within 15 days, pursuant to Rule 4901-1-28(E), O.A.C. Once objections, if any, have been filed, the Commission will determine if a hearing on the application is necessary.

(12) As noted in prior cases, although these projects are conditionally approved, as described above, they are subject to evaluation, measurement, and verification in the portfolio status report proceeding initiated by the filing of the applicable electric utility's portfolio status report on March 15 of each year, as set forth in Rule 4901:1-39-05(C), O.A.C.

It is, therefore,

ORDERED, That OEC's motion to intervene be granted. It is, further,

ORDERED, That the joint applications listed in Appendix A be approved, as delineated in finding (10). It is, further,

ORDERED, That a copy of this Finding and Order be docketed in each of the cases listed in Appendix A. It is, further,

ORDERED, That a copy of this Finding and Order be served upon all parties of record in this case, as well as the parties of record in each of the cases listed in Appendix A.
