Stoneco, Inc.'s Scott quarry is located at 2364 Richie Road, Convoy, Ohio. The quarry typically operates from approximately April through October as weather permits. The management of Stoneco, Inc. has been informed about the possibility of ice throw issues as a result of the wind farm project. We do not think that the presence of turbine 48, as it is currently proposed, will pose a safety risk to our employees, contractors, vendors, or customers. The management of Stoneco, Inc. supports the wind farm project and does not object to its development.
