Thank you for contacting the Ohio Power Siting Board regarding Heartland Wind LLC's proposed installation of a wind turbine electric generating facility located in Van Wert and Paulding Counties, Ohio. The OPSB's mission is to support sound energy policies that provide for the installation of energy and transmission infrastructure for the benefit of the Ohio citizens, while promoting the state's economic interests and protecting the environment and land use.

Further, the adjudicatory hearing will be called on July 15, 2010, at 10:00 a.m., at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215.

Should the Ohio Power Siting Board grant certification to construct, Blue Creek Wind Farm / Heartland Wind LLC will obtain and provide proof of all applicable permits and authorizations as required by Federal and State entities necessary for utility operations within the state of Ohio.

As we appreciate all input into the siting process, your document will be shared with members of the Board and placed in the official docket for this case.
