

The public hearing for Blue Creek Wind Farm / Heartland Wind LLC is scheduled on July 8, 2010, at 5:00 p.m., at the Lincolnview School, 15945 Middle Point Road, Van Wert, Ohio 45891, where the public is invited to give sworn testimony concerning this case.

Further, the adjudicatory hearing will be called on July 15, 2010, at 10:00 a.m., at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215.

Should the Ohio Power Siting Board grant certification to construct, Blue Creek Wind Farm / Heartland Wind LLC will obtain and provide proof of all applicable permits and authorizations as required by Federal and State entities necessary for utility operations within the state of Ohio.

As we appreciate all input into the siting process, your document will be shared with members of the Board and placed in the official docket for this case.
