Re: Notice of Assignment of Natural Gas Contracts in the Columbia Gas of Ohio service territory.

Dear Director:

Integrys Energy Services, Inc. is currently providing natural gas service to Choice and aggregation customers in the state of Ohio ("Customers").

In accordance with a corporate re-organization, Integrys Energy Services, Inc. will assign substantially all of its retail natural gas contracts (including its entire right, title and interest into and under the assigned Agreement) to its affiliate Integrys Energy Services - Natural Gas, LLC. This includes, but is not limited to, all of our Choice and aggregation Customer contracts for both residential and small commercial.

Due to a number of reasons, we will be assigning Customers in the Columbia Gas of Ohio service territory prior to Customers in other territories. The Columbia assignment will be effective as of August 1, 2010. Such assignment will effect approximately 17,431 Choice customers, including residential and small commercial Customers and one aggregation program with Fairfield Township. An additional notice will be sent to you when we assign our other Customers.

Attached you will find a copy of the notice sent to our Customers as well as the assignment agreement between Fairfield Township, Integrys Energy Services, Inc. and Integrys Energy Services - Natural Gas, LLC. This assignment agreement transfers the Natural Gas Aggregation Supply Agreement.

While the name of the Customers' supplier has changed, service will not change. Customers can expect the same high level of service and attention to detail from Integrys Energy Services - Natural Gas, LLC. as they enjoyed with Integrys Energy Services, Inc.

Customers are being notified the week of July 12, 2010 of the assignment.

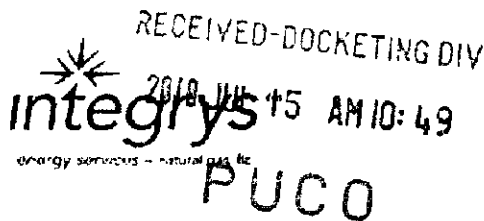


