ENTRY

The administrative law judge finds as follows:

- 1) On September 20, 1993, the Ohio Power Siting Board (Board) issued its Opinion, Order and Certificate in Case No. 91-1229-EL-BTX (91-1229) granting the application of the Ohio Edison Company (Ohio Edison) for a certificate of environmental compatibility and public need to construct a 138 kV transmission line in Marion, Delaware, and Union counties, between Ohio Edison's Crissinger and Tangy substations.
- 2) On June 23, and July 7, 1994, Ohio Edison filed four applications to amend the certificate issued in 91-1229, in accordance with Rule 4906-5-09 of the Ohio Administrative Code (O.A.C.). The amendment applications request authority to realign the certificated line route at the Crissinger Substation, and at locations on Tawa Road, Brindle Road, and Smart Road. These realignments are being

requested in accordance with the Board's directive that Ohio Edison seek to minimize the impact of the transmission line to farming operations, by placing the line so that it follows field and property lines.

3) In an effort to more easily track developments in each amendment application, these four amendments should be assigned new case numbers. Accordingly, all further filings made regarding the Crissinger Substation amendment should hereafter be docketed in Case Number 94-1212-EL-BTX. All further filings made regarding the Tawa Road amendment should hereafter be docketed in Case Number 94-1213-All further filings made regarding EL-BTX. the Brindle Road amendment should hereafter be filed under Case Number 94-1214-EL-BTX. All further filings made regarding the Smart Road amendment should hereafter be filed under Case Number 94-1215-EL-BTX.

It is, further,

ORDERED, That all further filings made regarding the Crissinger Substation, Tawa Road, Brindle Road, and Smart Road amendments be filed under the appropriate case docket identified in Finding No. 3. It is, further,

ORDERED, That a copy of this entry be served on all parties of record.
