

APPLICATION FOR CONTINUED PROTECTIVE TREATMENT OF FINANCIALS

COMES NOW NovaTel Ltd., Inc. ("NovaTel" or "Company"), Pursuant to P.U.C.O Rule 4901-1-24(4)(F), and hereby moves the Public Utilities Commission of Ohio for continued protective treatment of certain financial information submitted in support of the Company's original Application for Authority to Operate ("Application"), in Docket No. 09-493-TP-ACE on July 21, 2009. In support of this Motion, NovaTel Ltd., Inc. submits the following:

- (1) NovaTel remains a private, non-publicly traded company. As such, the Company has never filed financial statements with the SEC;
- (2) NovaTel continues to protect financial information from disclosure. This information is not generally available to those inside the Company without specific need-to-know, the information is kept in a secure location to prevent inadvertent disclosure. This information has not been released previously;
- (3) Public disclosure of the information would cause undue harm to NovaTel and would prove detrimental to the Company's ability to compete in the current telecommunications marketplace; and
- (4) Due to the sensitive nature of this information, it is appropriate for the Commission to continue to limit access. The information was provided in June 2009, for the sole use of the Commission in exercising their respective governmental functions in examination of

the Application for Authority. There remains no legitimate purpose to be served in disclosing this proprietary material to any person other than the appropriate reviewing staffs of the Commission.

WHEREFORE, NovaTel Ltd., Inc. respectfully moves that the Commission continue the Protective Order originally issued on August 6, 2009 in Docket No. 09-493-TP-ACE; and that the information remain confidential and proprietary for a period of not less than eighteen months.




