MEMORANDUM IN SUPPORT

The OCC requests a subpoena, pursuant to Ohio Adm. Code 4901-1-25, to command Joseph A. Miller, Jr., an employee of Duke Energy Ohio or one of its affiliated operations (collectively, "Duke"), to provide testimony at the hearing presently scheduled on September 7, 2010 at the offices of the Public Utilities Commission of Ohio ("PUCO" or "Commission") located at 180 E. Broad Street, 18th Floor, Columbus, Ohio 43215 at 10:00 a.m. The OCC asks that Mr. Miller be required to attend from day to day, until his testimony is completed, in order to provide testimony regarding the treatment of outages at the Zimmer Station, including the actual repairs and the replacement power that was required as the result of outages at the Zimmer Station.

The above-captioned cases all involve Duke's Fuel and Purchased Power ("FPP") rider as part of standard service charges. Charges connected with the operation of the Zimmer Station, including replacement power resulting from outages at the Zimmer Station, are part of FPP mechanism for charging customers. As an example of this connection

between the operation of the Zimmer Station and FPP charges as part of the instant cases, the docketed Management/Performance and Financial Audits of the Fuel and Purchased Power as Well as the System Reliability Tracker Riders of Duke Energy Ohio, Inc.

("Audit Report," docketed May 14, 2010) addresses the outages at the Zimmer Station and associated replacement power costs. Mr. Miller has been relied upon by Duke in response to the OCC's discovery requests regarding outages at the Zimmer Station, and he should be able to provide information regarding these matters in a manner not addressed by the Audit Report. The full participation of Mr. Miller will facilitate a full and complete development of these cases before the PUCO, including the ultimate record upon which the Commission will base its decision

Additionally, the OCC requests the PUCO to command Mr. Miller to bring with him on said day and at said place all documents in his possession and control, and in the possession or control of Duke (all forms of documents, including hard copies of information stored on electronic media), that provide the analysis relied upon by Mr. Miller and Duke to determine the amount of replacement power obtained as the result of outages at the Zimmer Station as well as the causes and manner of repair to the Zimmer Station during 2009. The documents should include those reports, analyses, and documentation provided by Duke in response to the OCC's requests for production by Duke.

The indicated information is important to understanding and addressing the issues related to Duke's proposed fuel and purchased power expenses, part of Duke's standard

service charges, and will more fully illuminate the statements contained in the Audit Report on this same topic.
