

## MEMORANDUM IN SUPPORT

On August 12, 2010, Commerce Energy, Inc. d/b/a Just Energy filed an application for renewal of Certificate No. 02-023, which authorizes it to provide competitive retail natural gas services. By Entry dated September 17, 2010, the Attorney Examiner scheduled the matter for hearing on October 14, 2010. On September 20, 2010, Staff filed its Staff Report of Investigation, which addressed consumer concerns and compliance issues regarding the Company's marketing practices.
