

OHIO EMISSION FEES RECOVERY

APPLICABILITY

Applicable to all jurisdictional retail customers, including interdepartmental sales, in the Company's electric service area.

CHARGE

Pursuant to Section 4905.31 (B)(2) and (B) (3) of the Ohio Revised Code, monthly bills, excluding fuel and any other rider adjustment, of all retail customers shall be increased by 0.0000 percent until the emissions fee levied pursuant to Section 3745.111, Revised Code, and paragraphs (C) and (D) of Section 3745.11, Revised Code are recovered. At such time, this rider shall be terminated.
