
BETTER COST CONTROL, LLC MOTION FOR PROTECTIVE ORDER

Better Cost Control, LLC, pursuant to Section 4901-1-24(D) of the Commission's rules (O.A.C. § 4901-1-24(D)) moves for a protective order keeping confidential the proprietary information designated with the heading "CONFIDENTIAL" on sections C3 and C5 contained in the Power Broker Application filed on November 1, 2010, as instructed in Section V of such application.

The reasons underlying this motion are based the fact that Better Cost Control, LLC is a private small business whose financials are not publically available and public disclosure of this information is an unnecessary invasion of applicant's privacy. Unlike electricity generation companies and suppliers, the financial position of a licensed broker is not is of importance to the people of Ohio, since the only role of the broker is to advise the customer and assist them to contract with licensed Suppliers. To release their financial information to the public could hurt their competitive position with other similar businesses licensed in the state of Ohio. Consistent with the requirements of Section 4901-124 (D) of the Commission's Rules, unredacted copies of the confidential information which is the subject of this motion have been filed with the application, under seal.
