Re: Possible First Energy All Electric Home Rate Solution

Per your letter of support, I am happy to report that R.W. Beckett Corp., www.beckettcorp.com did receive an Ohio Third Frontier Advancement Energy Grant to develop a "Distributed Energy Storage" device that can take power off the grid and store the power in Lithium-Ion battery cells that can be used during times of peak power demand to put power back onto the local grid. Per R.W. Beckett Corp., this device may

I believe this device could be used as a possible solution to the rate structure problem that First Energy, P.U.C.O. and all electric homeowners are facing.

Facts:

Mr. Schri

- 1. All-electric home electricity needs average out to approximately 25kWh per day. R.W. Beckett Corp. has designed their modular energy storage systems in 25kW/25kWhr. building blocks.
- 2. First Energy would own the device being developed by R.W. Beckett.
- 3. First Energy would work out a competitive lease arrangement with the homeowners in the subdivision to lease back the units over a 25 year time period.
- 4. First Energy could set up a rate structure whereby the utility would sell power at night to the homeowners at a reduced rate when electricity usage is low and the homeowners could then take their homes off the grid during the day and power their homes from the energy storage device.
- 5. This arrangement would be beneficial to both the homeowners and the utility. The homeowners of all-electric homes continue to get a break on their utility bill and the utility receives a reduction in electricity usage during the day to help reduce their peak power requirements.

I know that First Energy has interest in the "Distributed Energy Storage" device that Beckett is developing. If First Energy decides to test this device, I would suggest that First Energy use Bob Schmitt's Ridgefield Development, www.bobschmitthomes.com located in the City of North Ridgeville as a test lab for their grid testing. Another benefit regarding this test is that the subdivision is approximately four miles from the R.W. Beckett Corp. factory.


