BEGIN ON NOVEMBER 22, 2010**


Pursuant to Ohio Adm. Code Rule 4901-1-21(B), the Ohio Consumers' Counsel ("OCC") provided notice on November 9, 2010 to the parties and the Commission of its intention to take the oral deposition of all individuals whose testimony is filed on behalf of Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively "FirstEnergy" or "Company"). In addition, the OCC provided notice regarding oral depositions of all individuals identified in response to OCC discovery requests that were subject to a Motion to Compel that was granted on November 8, 2010, such response being due on November 15, 2010. Owing to the revised schedule for this case, including a new date upon which testimony must be submitted, the depositions are not expected to take place on November 22, 2010 as previously announced.

The above-mentioned depositions are not cancelled, but their date is under discussion between counsel for the OCC and FirstEnergy. Dates during early December are under consideration. The parties and the Commission will again be notified regarding final arrangements for the depositions.
