My husband and I wish to share our opinion and also state our discontent with the manner in which Ohio Edison has handled the AE Discount Issue.

We have been in our current home for the past 34 years having purchased it as a newly constructed home in our development. Our billing statement was billed as "Residential Optional Control Rider."

When it became available we had added a Load Management Control Unit (aka - Dencor Unit) to our home. This unit had kept our electric bills lower by the way it managed our electric. The Dencor unit worked to our benefit. As an example it would turn off the hot water heater and later turn it back on. The furnace heating elements would only let one element on at a time and then the other ones separately. It would also turn the heat off on the clothes dryer but allow the dryer to continue running. In essence it did the job it was created to do...it managed our electric in an efficient manner. When Ohio Edison requested us to increase to an 80 gallon water heater...we did so and had it installed.

In the 1980's when gas was available we had a visit from the gas provider. They were visiting the "all electric homes" in the hopes of having the homeowners switch over to Natural Gas. Our budget at this time was only \$99 per month. When this fact was offered to us we were advised to by the gas provider to keep what we had as they could not even come close to matching or beating this budget rate.

Now mind you... had we opted to pursue this even against the gas provider's advice and remarks the cost would have been \$6,000 for a new furnace and A/C unit. This price did not include the cost to actually run the gas line into our home nor having it hooked up to our water heater. For the record...our present heat pump and furnace were installed in 1999 at a cost of \$6,000.

Our lifestyle as homeowners, as well as senior citizens, has been greatly impacted because of the increased cost of electricity. We are unable to keep the heat to low as my arthritis and back issues will not tolerate it too cold and being the soul household worker in our home... this is great must.

My husband is legally blind and has a hearing disability to which we live with, and manage with these disabilities, as best as we can. The one health issue of his that we cannot ignore is his need for oxygen. The machine must run in order to provide him this and that takes electric...costly electric. He also needs lights on in the day time so he can see the shadows in order to maneuver through the house.

Our September 3, 2010 billing from Ohio Edison is still charging as "residential Service". It is unfair to have some individuals which like us, have an all electric home, receiving a discount on their rate while other home owners meeting the same criteria, such as my husband and I...do not benefit from nor are we afforded this same discount.

It is also unfortunate that our "Budget Amount" each month changes. The purpose of a budget is to keep it at the rate so you know what amount to expect to pay between readings. Our daughter and son-in-law live in Lorain have a budget which

remains the same as budget should. When it changes it does so only if need be and only when the account is reviewed each quarter.

If there is a balance owing on the EPP account it is expected to be paid immediately and in no uncertain terms we were advised it would be done so in that manner. Being a senior citizen, being disabled and being on a fixed income are not excuses...this is called reality.

We chose to live in our neighborhood, purchased our home and paid our home off over many years. Being on a fixed income and not being in great health is a disadvantage to us for we have no means to gain added income to not only stay warm but to function and deal with our health issues.

Our home we have kept with. It has not fallen into disrepair both inside and outside. The only downfall to any potential home buyer will be the utility costs, namely the cost of electricity.

In closing we want to again state our disappointment in the removal of the discounted rate. We invested in devices and upgrades to our home based on our belief that we were being good stewards of our savings and being proactive in maintaining our home in a positive manner. This is not the case at all.

**Bring back the discount across the board** and live up to the expectations you presented.
