## (5) End User Port FUSF Surcharges

When a customer is assessed a BRI ISDN Port Charge as discussed in Section 4.1.6(A)(13) (c) preceding, a FUSF Surcharge will also be assessed to recover the FUSF Surcharge obligation associated with each interstate end user charge as set forth in Section 4.1.7(C) following.

## (6) Other Non-recurring FUSF Surcharges

In addition to the applicable charges above, when a customer is assessed interstate end user charges identified in the table below, a FUSF Surcharge will also apply as set forth in Section 4.1.7(C) following. For example, customers assessed the PIC change charge as specified in Section 4.2. (B) (6) (c) will also be assessed the PIC change FUSF Surcharge as set forth in Section 4.1.7(C) following.
