EXHIBIT D

The following AT&T Ohio bill page message was printed on the bills of impacted residential customers from **11.3.2010** through **12.2.2010**.

RATE INCREASE

Effective 1/7/2011, the monthly Line Charge rate for residential access lines will increase from \$6.70 to \$7.95. Customers with certain packages and bundles will not be affected by the increase. Please note: While you may have previously received a notice about a 10/3/2010 rate increase for the Line Charge, that increase was not implemented. To learn more about our money-saving packages, products or services, please visit us online at att.com or call 1.800.288.2020.

Note: A residential customer's local exchange service consists of <u>three tariffed</u> components: a network access line, a central office termination and usage. However, these three <u>tariffed components</u> are displayed as <u>two charges</u> on the customer's bill, a Line Charge and a usage charge. For example, for flat rate local service, using rates in effect prior to 1-7-2011, the rate is calculated and shown on the bill as follows:

Network Access Line	\$ 4.40 —	Displayed as CC 70 "Line Charge" on the bill
Central Office Termination	\$ 2.30	Displayed as \$6.70 "Line Charge" on the bill.
Flat Rate Usage	\$ 7. <u>55</u>	Displayed as "Unlimited Residence Service" charge on the bill.
Total	\$14.25	

Customer bills display a Line Charge of \$6.70, which is a combination of the network access line rate (\$4.40) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 1-7-2011 rate increase, the tariffed rate for a residential network access line will increase by \$1.25, going from \$4.40 to \$5.65. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$6.70 to \$7.95. So, for flat rate local service, using rates in effect subsequent to 1-7-2011, the rate will be calculated and shown on the bill as follows:

Network Access Line	\$ 5.65 \$ 2.30	Displayed as \$7.05 "Line Charge" on the hill
Central Office Termination	\$ 2.30	Displayed as \$7.95 "Line Charge" on the bill.
Flat Rate Usage	\$ 7. <u>55</u>	Displayed as "Unlimited Residence Service" charge on the bill.

In order to provide consistency between the customer notice and the information displayed on customer bills, the customer notice was written to indicate that the Line Charge rate will be increasing from \$6.70 to \$7.95. Thus, customers affected by the rate increase will see their bill for flat rate local service increase from \$14.25 to \$15.50 (\$7.55 + \$7.95). The Line Charge rate for message and measured rate residential service is likewise increasing, while usage rates are not.
