Pursuant to Ohio Adm. Code Rule 4901-1-21(B), the Ohio Consumers' Counsel ("OCC") provided notice on November 9, 2010 to the parties and the Commission of its intention to take the oral deposition of all individuals whose testimony is filed on behalf of Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively "FirstEnergy" or "Company"). 


