REVISED NOTICE TO TAKE DEPOSITION UPON ORAL EXAMINATION  
AND REQUEST FOR PRODUCTION OF DOCUMENTS

Pursuant to Ohio Adm. Code Rule 4901-1-21(B), the Ohio Consumers' Counsel ("OCC") gave notice to take the oral deposition of all individuals whose testimony is filed on behalf of Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively "FirstEnergy" or "Company"). The depositions that were to originally take place on November 22, 2010 were delayed, as parties were notified on November 17, 2010. A deposition has been rescheduled (per an agreement between counsel for the OCC and FirstEnergy) as follows: the deposition of Bill Ridmann will take place on January 24, 2011, beginning at 10:00 a.m. at the FirstEnergy offices located at 76 South Main Street, Akron, Ohio 44308. Parties to the proceeding are invited to attend and cross-examine. A telephone call-in number will be provided to counsel for parties to the case by a subsequent e-mail.




