**COLUMBUS SOUTHERN POWER COMPANY'S APPLICATION FOR
APPROVAL OF A CHANGE IN BILL FORMAT AND REQUEST FOR AN
EXPEDITED REVIEW**

Pursuant to §4901:1-10-22 (C), Ohio Admin. Code, Columbus Southern Power Company (CSP) files this application for Commission approval of a change in bill format. CSP also requests that the Commission consider this application on an expedited basis because the underlying compliance tariffs the format changes are based upon became effective January 14, 2011.

On December 1, 2010, the Commission approved changes to Columbus Southern Power's service to allow for experimental service offerings in time of day (TOD) service rates and direct load control (DLC) experimental service. The Commission ordered CSP to file, in final form, four complete copies of its tariff, consistent with the finding and order. CSP filed the revised tariff sheets on January 13, 2011.

The Companies must update the language on its bill to reflect these tariff changes. CSP previously requested approval for bill format changes applied to TOD service rates. (See January

13, 2011 Application for approval of a change in bill format filed in Case No. 10-424-EL-ATA, 11-178-EL-UNC). CSP now seeks authority for certain bill format changes for new DLC service. A copy of CSP's current bill with the proposed new text included is made part of this application as Attachment 1.

CSP has already discussed with and provided the Commission staff with a copy of the requested format change to ensure their input was received before filing with the Commission. The Company is moving forward with this filing under the guidance of Commission Staff.

For these reasons, the Columbus Southern Power Company requests that the Commission approve their new bill format on an expedited basis.
